We would like to inform all participating countries that require a visa to enter Indonesia that the recommended visa for entering Indonesia is the B1 type visa, which can be conveniently applied for through the Electronic Visa on Arrival (e-VOA) system via the official Indonesian Immigration website: https://evisa.imigrasi.go.id

Please ensure that you apply for and print your visa before departing from your country. It is **NOT** recommended to apply for the visa upon arrival at the airport in Soekarno-Hatta International Airport (CGK), Tangerang, Banten Indonesia. Kindly note that the Organizing Committee will not process visas on behalf of participants.

- A scanned copy of your passport (valid for at least 6 months before departure)
- A recent personal photo complying with official guidelines (see attachment)
- A return flight ticket




