REGULATIONS

2025 United States National and US Open International SAMBO Cup

April 5, 2025

Atlanta, Georgia, USA

1. GENERAL CONDITIONS

- 1.1 The 2025 United States National and US Open International SAMBO Cup will be held in accordance with the FIAS Regulations for Organizing and Holding of the Official FIAS Competitions and the International SAMBO Rules.
- 1.2 The 2025 United States National and US Open International SAMBO Cup will be held to promote and develop SAMBO in the Pan American continent and to strengthen international relations.
- 1.3 Conditions of participation: sambo athletes who are members of their respective national federations and are above 18 years of age
All competitors must present a valid health insurance.

2. FACILITIES

2.1 United States National and US Open International SAMBO Cup will be held at the Georgia International Convention Center (GICC), Atlanta, GE, USA.

3. TRANSPORTATION

The GICC is conveniently located one-quarter mile from the **Hartsfield-Jackson Atlanta International Airport**. It is connected to a major airport by the free **ATL SkyTrain**; it is just as convenient by car — at the juncture of two major U.S. interstates. The heart of Atlanta is 10-minutes away by rental car or **MARTA** transit. And the airport's Rental Car Center links to the GICC by the **ATL SkyTrain**.

Transportation to and from the airport is individual responsibility.

4. COMPETITION RULES

The Competitions will be held according to the Regulations for Organizing and Holding Official FIAS Competitions.

4.1 Competition Disciplines

- Sport SAMBO: Men & Women
- Combat SAMBO: Men & Women

4.2 Competitor's Age

- Sport sambo: starting 17 years of age and older.
- Combat sambo: 19 years and older.

4.3a Weight categories for US Nationals are those internationally accepted by FIAS

- Sport SAMBO Men: 58kg, 64kg, 71kg, 79kg, 88kg, 98kg, +98 kg
- Sport SAMBO Women: 50kg, 54kg, 59kg, 65kg, 72kg, 80kg, +80 kg
- Combat SAMBO Men: 58kg, 64kg, 71kg, 79kg, 88kg, 98kg, +98 kg
- Combat SAMBO Women: 50kg, 54kg, 59kg, 65kg, 72kg, 80kg, +80 kg

4.3c Weight categories for US Open International Cup are modified as follows:

USA Sambo Inc.

- Sport SAMBO Men: 64kg, 71kg, 79kg, 88kg, + 88kg
- Sport SAMBO Women: 54kg, 59kg, 65kg, 72kg, , + 72kg
- Combat SAMBO Men: 64kg, 71kg, 79kg, 88kg, + 88kg
- Combat SAMBO Women: 54kg, 59kg, 65kg, 72kg, + 72kg

4.4 Number of Athletes and Team Officials of the delegation for US Open International Cup

Up to five (5) US athletes are allowed to register per weight division and two (2) international athletes from the respected national team per weight category are allowed to participate in the event. An athlete can participate in both sport and combat disciplines, and according to the FIAS Rules.

5. ACCREDITATION AND OFFICIAL REGISTRATION

Registration of athletes and coaches shall be made on line. The instructions will be listed on our website: <https://usasambo.com/>

The Accreditation will be held at the weigh-ins

6. WEIGH-IN

The weigh-in will be held according to the current FIAS Regulations. Same athlete may compete in more than one weight category. Time and place of the weigh-in will be indicated at a later date.

7. UNIFORMS AND EQUIPMENT CONTROL

All competitors shall wear uniforms and equipment approved by the International SAMBO Federation (FIAS). At all times athletes shall comply with the Regulations for Organizing and Holding Official FIAS Competitions and FIAS Rules. Failure to comply with the rules and regulations pertaining to the control of uniforms and equipment entails penalties for the coach or athlete in the event.

8. VISA

The Organizing Committee is pleased to provide all possible support so that the National Federations of each country can obtain the corresponding visa in order to enter USA. Please note that USA Sambo will not respond to individual inquiries, but only through the appropriate National Sambo Federation.

9. AWARDING

9.1 Athletes Awarding

The awarding protocol indicates that athletes must wear their red uniform at the time of the Awarding Ceremony.

Athletes will be awarded in the following way:

- First Place: Gold Medal
- Second Place: Silver Medal
- Third Place: Bronze Medal

10. REFEREES

The referees for the event will be appointed by the FIAS Technical Commission according to the current procedure and regulations. The other referees must be authorized by their SAMBO National Federations.
