









REGULATIONS WORLD SAMBO CHAMPIONSHIPS 2025 (M&W, COMBAT) BISHKEK, KYRGYZSTAN

1. GENERAL TERMS

- 1.1 The World SAMBO Championships 2025 (M&W, Combat SAMBO), hereinafter the Championship, shall be held in accordance with the FIAS Regulations for Organizing and Holding of the Official FIAS Competitions (Sports and Organizational Rules) and the International SAMBO Competition Rules.
- 1.2 The Championship is organized to define the strongest athletes in corresponding age group as well as to promote and develop SAMBO worldwide and to strengthen the international relations.

2. COMPETITIONS' ORGANIZERS

2.1 General management of the organization and holding of the Championship 2025 shall be the responsibility of the International SAMBO Federation (FIAS) and Sambo Federation of the Kyrgyz Republic.

4. TERMS OF PARTICIPATION

- 4.1 The National SAMBO Federations (NSF) affiliated to FIAS have the right to take part in the Competitions. The NSF should pay the FIAS annual membership fee before the Competitions in order to be able to take part in the Competitions.
- 4.2 According to the Organizing and Holding of the Official FIAS Competitions each competitor is obliged to have a back number comprising his last name and his National Country name abbreviation on the back of his SAMBO uniforms (red & blue). Athletes who do not have a back number affixed on the back of their SAMBO jackets will not be allowed to compete.
- 4.3 Each National SAMBO Federation should cover the cost of athlete's license **60 USD**, which includes **the international sports insurance** for the selected competitions from FIAS calendar. - 4.4 Each National SAMBO Federation's coach should have a FIAS coaches' certificate and cover the cost of license 60 USD, which includes the international sports insurance for the selected competitions from FIAS calendar.

4.6 All delegations should provide the Organizing Committee with a short version (not more than 30 seconds) of corresponding national anthem in electronic format (soft copy) and two national flags 2x1m.

5. TECHNICAL TERMS

- 5.1 The Championship shall be held in accordance with FIAS Sports and Organization Rules and the International SAMBO Competition Rules. Officiating of the Competition shall be entrusted to the Panel of referees approved by the Chairman of FIAS Technical Commission.
- 5.2 Only international category referees, who were appointed by the Chairman of FIAS Technical Commission will be able to officiate the competition.
- 5.3 Draw will be conducted automatically through the FIAS Electronic System (random selection/distribution) in accordance with the international FIAS Rank List 2025 in each weight category.
- 5.4 FIAS Sport SAMBO official competitions shall be held with the system of distribution into groups, elimination and repechage bouts from finalists. FIAS Combat SAMBO official competitions shall be held with the system of distribution into groups and elimination without repechage bouts. Team medal count is conducted according to the Olympic principle.
- 5.5 The Organizing Committee guarantees to provide all the participants with the first aid (if necessary).

6. ANTI-DOPING

- 6.1 The doping tests are carried out by the official Anti-Doping organization or sample collection provider recognized and approved by WADA.
- 6.2 The selection of athletes would be according to the 2021 FIAS Anti-Doping Rules, which are based on 2021 WADA Anti-Doping Code. After receipt of notification until arrival at the point of doping control the selected athletes will be always accompanied by the official representative of the organization. The selected athlete has right to be accompany by one representative who helps him with translation.
- 6.3 The official language during the doping control is English.
- 6.4 If the Organizing Committee does not provide participants with accreditation with the photo on it the selected athlete will be required to provide a valid passport or identity document at the point of doping control. All athletes are required to plan in advance the date and the time of their departure from the competitions taking into consideration that any athlete could be chosen for the doping test.
- 6.5 The Anti-Doping Seminar will be held in «The Plaza Hotel Bishkek», Address: Bishkek, Togolok Moldo st., 52, on 06 November 2025, and will be compulsory for all Athlete Support Personnel. The athletes are invited to attend the seminar and follow the WADA outreach programme during the event.

7. ENTRIES

7.1 Registration of the athletes is made **ONLY** by means of the **FIAS Electronic System (FIAS Database)** at https://fms.sambo.sport/login. Admission of the athletes to the competitions will be carried out only through the Database. 7.2 All fees related to a visa to enter Kyrgyzstan, which may be applied to each participant, must be paid independently by the relevant national SAMBO federation or an individual participant. Visas are processed through the e-visa portal of the Ministry of Foreign Affairs of the Kyrgyz Republic (https://www.evisa.e-gov.kg/index.php?lng=en).

The SAMBO Federation of the Kyrgyz Republic, as an inviting party, will provide a package of necessary documents for processing an electronic visa only to those delegations that will apply through the FIAS database.

After successful registration of the application in the e-VISA system, it is necessary to immediately provide the Sambo Federation of the Kyrgyz Republic (E-mail: kyrgyzstan@sambo.sport, WhatsApp: +999 779 659 681) with the reference number assigned to the application by the system to organize tracking of its consideration and issuance of a visa.

7.3 National SAMBO Federations that fail to submit their entries by **1 October 2025**, through the **FIAS Database** will be obliged to pay the fine of **200 USD** per each delegate, who is not registered for the competitions (FIAS Database registration onsite will be obligatory anyway).

7.5 Mass media representatives will pass additional accreditation process at the FIAS official website: https://sambo.sport/en/media/press/ not later than November 1, 2025.

8. FINANCIAL CONDITIONS

- 8.1 Each delegation member must pay the Organizational Fee to the Organizing Committee at the amount of 100 USD per person per day for double accommodation and 150 USD per person per day for single accommodation (accommodation only in the official hotels and 2 times a day meal breakfast and dinner). Accommodation period is 4 days minimum for each delegation member (official hotels only). Congress Delegates and Heads of Delegations must pay the Organizational Fee to FIAS at the amount of 150 USD per person per day at «Orion Hotel Bishkek».
- 8.2 **Transfer** from **"Bishkek" airport** to the official Championship hotels and back, and during competitions from official hotels to the competition venue and back **costs 20 USD** for each delegation member and to be paid by the respective National Federation.
- 8.3 The Heads of Delegations shall settle all financial issues and meet accreditation requirements on the day of arrival. Payment to be made in **US dollars**. In case of non–cash payment using bank details (clause 11), payment is made in euros, at the exchange rate on the day of payment.

9. SPECIAL CONDITIONS FOR THE PARTICIPATION OF BLIND ATHLETES

- 9.1 Blind athletes participate in the World Championships in the SVI1 class among men in the weight categories: -64, -79, -98 kg.
- 9.2 Classification procedures before the World Championships:

It is necessary to provide (send to the email address newmoscow80@yandex.ru) a completed medical diagnostic form (MEDICAL DIAGNOSTIC FORM (MDF) FOR SAMBO ATHLETES WITH VISUAL IMPAIRMENT) no later than **October 1, 2025.**

MDF forms must be filled out ONLY in English.

Participants are given 1 week to correct an incorrectly completed form.

- 9.3 Blind athletes must be classified before the weigh-in. Place Hotel «Jannat Regency Bishkek» (Tokombaev street, 21/2); time from 10:00 to 18:00, November 6, 2025.
- 9.4 During classification, a completed classification form for athletes with visual impairment (blind and visually impaired) must be provided to the classifiers before the start of the assessment. Points 1, 2, 3 of this form must be completed by the FIAS Member National Federation and the athlete in advance of the classification. The Athlete Consent Form and Accompanying Person and Interpreter Confidential Obligations, which are attached to the classification form, must be read prior to classification, but signed only at the time of classification.

10. AWARDING

- 10.1 Prize-winning athletes shall be awarded with medals, diplomas and prize money.
- 10.2 The prize fund of the World Championships amounts to **341,000 US dollars**. Each prize-winning athlete should submit his/her **USD bank account details** before **November 30, 2025** to <u>info@sambofias.com</u> and <u>finance@sambofias.com</u> in order to FIAS financial department could arrange corresponding payments.
- 10.3 The breakdown of prize money for the disciplines Sport SAMBO M&W, Combat SAMBO M&W will be the following:

Gold medallist – 4,000 US dollars;

Silver medallist - 3,000 US dollars;

Bronze medallists – 2,000 US dollars each.

The breakdown of prize money for the discipline Blind SAMBO Men will be the following:

Gold medallist – 4,000 US dollars;

Silver medallist - 3,000 US dollars;

Bronze medallists – 2,000 US dollars each.

- 10.4 Red SAMBO uniform is required at the official ceremonies.
- 10.5 During the awarding ceremony national anthem will be played along with raising a flag.
