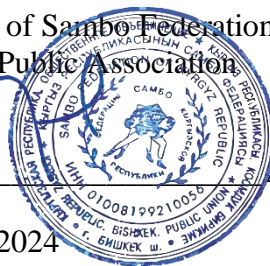

**REGULATIONS**  
of the 2024 World SAMBO Cup  
(Sports SAMBO M&W, Combat SAMBO M&W)

## 1. Competitions Objectives

- Popularization of SAMBO in the world;
- Improving the skills of athletes;
- Strengthening friendly sports ties;
- Ranking selection of athletes (Combat SAMBO, Men and Women) for the 2025 World Games (Chengdu, China).

## 2. Dates and Venue

The World SAMBO Cup (Sport SAMBO M&W, Combat SAMBO M&W) (hereinafter the Competitions) will be held in Cholpon-Ata city on August 13-20, 2024, including the arrival day (August 13-14, 2024) and the departure day (August 20, 2024).

Venue of the Competitions: Gazprom Sports Complex, Cholpon-Ata city, August 15-16, 2024.

Accreditation Venue: "Issyk-Kul Aurora" Sanatorium, Bulan-Sogottu village, on August 14, 2024.

Venue of referees accommodation: "Issyk-Kul Aurora" Sanatorium, Bulan-Sogottu village.

Venue of athletes accommodation and sports camp: "Issyk-Kul Aurora" Sanatorium, Bulan-Sogottu village.

## 3. Competitions Organizers

General management of the preparation and holding of the Competitions is carried out by the International SAMBO Federation (hereinafter the FIAS), the Ministry of Culture, Information, Sports and Youth Policy of the Kyrgyz Republic (hereinafter the Ministry), "Sambo Federation of the Kyrgyz Republic" Public Association (hereinafter the Federation).

The powers of the Ministry as the organizer of international competitions are exercised by the Department of Physical Culture and Sports of the said Ministry.

The direct holding of the Competitions is entrusted to the Federation and the panel of referees approved by the FIAS.

## 4. Terms of Participation

Competitions are held in accordance with the Regulations for organizing and holding of official FIAS competitions (Sports and Organizational Rules) (hereinafter the Regulations). The World Cup is held in one stage – the final.

Competitions are held in the following weight categories:

- Sport SAMBO (men) – 58, 64, 71, 79, 88, 98, + 98 kg;
- Sport SAMBO (women) – 50, 54, 59, 65, 72, 80, + 80 kg;
- Combat SAMBO (men) – 58, 64, 71, 79, 88, 98\*, + 98 kg;
- Combat SAMBO (women) – 54, 59, 65, 72, 80\* kg.

Athletes (Year of birth 2006 and below) of national teams representing National SAMBO Federations that are members of the FIAS are allowed to participate in the Competitions.

Composition of the delegation – 58 people, including athletes – 52 people, coaches – 4 people, doctors – 1 person, team manager – 1 person.

The number of athletes from the country shall be not more than 2 in each weight category.

*\*Ranking selection of athletes (men and women, Combat SAMBO) for the 2025 World Games (Chengdu, China).*

## 5. Accreditation

Registration of teams for the Competitions is carried out through the FIAS Online System (FIAS Database) at: <https://fms.sambo.sport/login>

To enter the personal account of each NSF, one shall receive a login and password for the system, as well as instructions for using the system. Athletes' access is permitted through the FIAS system only. For registration in the System, please contact the FIAS office: Tel. +7 (495) 411-61-37, [info@sambo-fias.com](mailto:info@sambo-fias.com).

During the accreditation, managers of the teams participating in the Competitions shall provide to FIAS the documents confirming the payment by the National Sambo Federation of the annual FIAS Membership Fee (payment order with a bank note on debiting funds).

Heads of delegations shall also provide the secretariat with the following documents: application copy, passport or ID card.

## 6. FIAS License and Insurance

Each athlete\* and coach\*\* is required to register in the FIAS Database and to have the FIAS license with payment of a membership fee for the current year.

The cost of the FIAS license is 60 US dollars, which also includes international sports insurance for a specific list of competitions in the FIAS calendar. These competitions are included in the insurance program for 2024 (the terms and conditions of Insurance are provided on request of the NSF at [info@sambo-fias.com](mailto:info@sambo-fias.com); the obligation to familiarize the athletes and officials with the Insurance Rules in advance applies to the NSF). Each participant who pays the FIAS license fee in the amount of 60 US dollars automatically enters the insurance program and gets the medical sports insurance. The rules of the insurance program do not prohibit having any other insurance, while the cost of the license remains the same, i.e. 60 US dollars.

Licenses and insurance of participants in the Competitions are paid by the National SAMBO Federations participating in the Competitions.

\* An athlete who has not registered in the FIAS Database and has not paid the membership fee for the current year will not be allowed to participate in the World Cup.

\*\* A coach without a certificate of the appropriate level, without registration in the FIAS Database and who has not paid the membership fee for the current year, can attend the World Cup as a spectator only (will not be allowed into the competition area).

## 7. Anti-Doping

Anti-Doping control is carried out by the National Anti-Doping Agency of the Kyrgyz Republic, accredited by the WADA. The selection of athletes will be made in accordance with the requirements of the FIAS Anti-Doping Rules 2021, based on 2021 WADA Code.

From the moment of notification until arrival at the doping control station, the selected athletes will be accompanied at all times by an official representative of the organization. The selected athlete may also be accompanied by 1 representative to assist with translation. The official language used during the doping control procedure is English. If the Competition Organizing Committee fails to provide accreditation with photo, the selected athlete will be required to provide a valid passport or other identity document at the Doping Control Station.

All heads of the teams are required to plan the date and time of departure after the end of the competition, taking into account that any athlete may be selected for doping testing.

### **8. Summing up**

The order of fights, determination of the winners and prize-winners of the Competitions are carried out in accordance with the International Rules of sambo competitions (Sports and Combat). Competitions are defined as individual.

### **9. Awarding**

The winners and prize-winners of the Competitions in each weight category are awarded with medals and diplomas.

Other organizations may provide additional awards and commemorative prizes.

### **10. Financial Conditions**

The costs of sending participants to the Competitions are covered by the sending organization. The heads of sports delegations shall resolve all financial obligations with the organizing committee on the day of arrival and fulfill all accreditation requirements and pay at the rate of 100 US dollars for each day of competition with meals (two meals a day) including the days of arrival and departure. Transfer Tamchy airport (Issyk-Kul) – hotel – competition hall – Tamchy airport (Issyk-Kul) is 20 US dollars per person; transfer Manas airport (Bishkek) – hotel – competition hall – Manas airport (Bishkek) is 40 US dollars per person (the distance from Manas airport to Cholpon-Ata is 273 km). The cost of living in a sports camp is 50 US dollars per person. The price includes 3 meals a day. Check-in time is 15:00 PM, check-out time from hotels is 12:00 PM.

### **11. Press**

The Organizing Committee of the Competitions provides all the necessary conditions for the work of the press representatives in accordance with the FIAS Press Guidelines.

To obtain accreditation, media representatives shall first fill out the appropriate form in the "Media Center" - "Accreditation" section on the official FIAS website at [www.sambo.sport](http://www.sambo.sport), indicating in the "Comments" section the name of the competition, i.e. the World Sambo Cup 2023. The form shall be filled out no later than **13 August 2024**, and the accreditation form (full name, publishing house name, contact phone number) shall be duplicated (send copy) to e-mail of the Sambo Federation of the Kyrgyz Republic at [kyrgyzstan@sambo.sport](mailto:kyrgyzstan@sambo.sport).

### **12. Television**

All rights to the television broadcast of the Competitions belong to the FIAS. The Organizing Committee ensures the broadcasting of the Competitions in accordance with the FIAS Television Guidelines.

### **13. Marketing and Advertising**

The Organizing Committee of the Competitions guarantees the observance of sponsorship rights to the FIAS partners and sponsors, provided for in the FIAS Marketing Guidelines.

### **14. Entries**

Applications for participation in the Competitions are submitted by the National SAMBO Federations no later than **July 10, 2024** in accordance with the Regulations.
